0105/1920 **PLANNING APPLICATION – AMENDMENT TO 17/01033/EIA**

Erection of four poultry buildings with feed bins, one gate house, one boiler house and circular water tank; and associated infrastructure and landscaping scheme – Footbridge Farm, Tasley, Bridgnorth, WV16 5LZ

At the Town Council meeting held on 18 June 2019, Members were asked to consider the amendments to the above application where it was:

**RESOLVED:**

- i. To object to the subject planning application (in general terms, in line with the previous submission - *minute 0227/1718 dated 23 Aug 2017 refers*).

- ii. To delegate the matter to the Town Council's Planning Committee to approve a precise form of words that are consistent with the views discussed (to object) that could be submitted to the Local Planning Authority.

It was:

**RESOLVED:** that the following submission (to object) be sent to Shropshire Council on behalf of the Town Council in response to amended application 17/01033/EIA.

'The Council reiterates the concerns about the proposed development set out in its comments of 24<sup>th</sup> August 2017 but notes that it is not now proposed to spread the manure generated by the operation of the Livestock Unit as fertiliser.

The Council noted that Shropshire Council introduced interim guidance on how it would assess the impact of ammonia emissions from Livestock Units in April 2018, and that the government's Clean Air Strategy published in January 2019 identified ammonia pollution as presenting a risk of biodiversity loss and potentially impacting human health (in particular where high levels of Nitrogen Dioxide pollution is present). The Council further noted that the revised Ammonia Report projects that there would be an increase in atmospheric ammonia concentrations in residential areas to the West of Bridgnorth Town and at Thatcher's Wood and Westwood Covert SSSI. The Council is concerned that the impact of the additional ammonia concentrations on the built up area of Bridgnorth (and in particular Bridgnorth Pound Street AQMA) and at Thatcher's Wood and Westwood Covert SSSI has not, at present, been assessed and that no avoidance or mitigation measures are currently proposed.'

19/02449/FUL Erection of 2 no. detached bungalows – Proposed Residential Development Land North of 9 Oldbury Wells, Bridgnorth, Shropshire

**Object on the grounds that this does not meet the conditions of the outline permission granted in January 2017 (17/00015/OUT) which was given for two x 2 bedroom properties whereas these are 3 bedroom properties. Also object on the grounds of inadequate access to the properties with the only parking available being in adjacent streets, plus concerns over the delivery of materials during construction and associated disruption to traffic.**

19/02486/FUL Installation of replacement windows to all flats (Nos 1 – 10) – Mold Court, Bridgnorth, Shropshire

19/02515/FUL Erection of dormer roof to rear of dwelling – 16 Hillside Avenue, Bridgnorth, WV15 6BT

**No objection.**

19/02621/FUL Erection of single storey detached Japanese style summer house – Severna, Love Lane, Bridgnorth, WV16 4HE

**Object to the application as submitted as insufficient information has been provided.**

19/02679/TCA Reduce and reshape to pollard points (see photo) 1 no Cherry within Bridgnorth Conservation Area – 3 St. James Cottage, Stourbridge Road, Bridgnorth, WV15 5AH

***Members support this application.***

19/02697/FUL Erection of a single storey side and front extension – 1 Wrekin Road, Bridgnorth, WV16 4NY

***No objection but it is noted that the proposed extension extends beyond the front of the building line.***

19/02698/FUL Replacement of existing fascia, projecting and ATM signage, works to include the preparation and decoration of existing shopfront and replacement of existing ATM and surround – 58 High Street, Bridgnorth, WV16 4DX

***No objection.***

19/02699/ADV Erect and display 1 no externally illuminated fascia, 1 no projecting externally illuminated sign and 1 no ATM face illuminated tablet (new branding) - 58 High Street, Bridgnorth, WV16 4DX

19/02815/OUT Outline application for the erection of 5 no dwellings to include means of access and scale – Proposed Residential Development Land North of Oldbury Wells School, Oldbury Wells, Bridgnorth

***Object to the proposed development in its current form on the grounds that the footpath is too narrow and there is already too much traffic passing at peak times to the schools meaning buses have to mount the pavement. Members consider that the proposed development is too close to the road.***

19/02819/FUL Erection of two new steps – 28 West Castle Street, Bridgnorth, WV16 4AD

***Members object as they would prefer to see two rectangular steps in keeping with current styles and***

***that they should not extend more than 500 mm in total.***

19/02881/FUL      Erection of 1 no detached bungalow – 20 Sydney Cottage Drive, Bridgnorth, WV16 4PQ

***Object on the grounds of there being insufficient space to locate the building on this site. Members also noted the comments submitted on behalf of the Local Highway Authority.***
