10. Shropshire Council Community Tree Scheme

Members are asked to consider the following correspondence.

"We now have some additional funding available to supply free of charge some large, feathered trees (1-1.5m tall, bare root). 'Feathered' trees are larger than the transplants provided through the Community Tree Scheme, and so would be more suitable for locations such as wide road verges or village greens, for example, where they would be more prominent visually. If you are interested in a single, a few, or a larger number of feathered trees for planting where they will be a public benefit, please apply to us using the attached form.

Please note that the choice is limited to the following species:

English Oak Wild Cherry Silver Birch Red Oak Common Alder

Please be aware that applicants must be able to collect their trees from either Prees Heath Forest Nursery, which is located at Higher Heath in the north of the county, or from John Holliday (formerly Potters Farm Tree Nursery), at Lower Hayton, north of Ludlow. Please don't apply if you're not willing or are unable to collect your trees from one or other of these locations

We would like to be able to notify the nursery of how many feathered trees to put aside for us by the end of September and hope to have them ready for distribution sometime in December."
