<u>Bridgnorth Club For Young People</u> - Mrs Dixon of St Johns Street had noted the minutes of the Annual Town Meeting in relation to the Club for Young People and the Town Clerk's response that 'concerned residents should contact the Charity Commission directly...'; she asked why then the Council had taken the matter on?
