#### 0268/1920 BUDGET 2020/21

Members considered a budget report from the Responsible Finance Officer (RFO) and a 2<sup>nd</sup> draft budget. Members noted that the draft budget was predicting a 5.9% increase in the precept; an increase of £7.93 per band D household with a predicted level of the general reserve at the end of FY 20/21 being £160,000.

It was noted that the draft budget did not currently include any increases to Town Council fees and it was suggested that the RFO consider some significant fee increases to certain services (room/ hall hire predominantly) but with a discounted rate for regular users and Bridgnorth registered charities.

It was acknowledged that in the current year there has been some unbudgeted expenditure including: 2 elections costing £6k, waiving of service charges to Bridgnorth Community Hall £10k and LED upgrade to Street Lighting £39K (albeit the LED upgrade is anticipated to achieve a £5k per year saving in electricity costs).

Some discussion took place about the provision of public toilets; making them free of charge, closure where use was low and an acknowledgment that the new session of parliament had not confirmed that the previous administrations proposal to remove business rates from public toilets (a current cost of some £7k to Bridgnorth Town Council).

CCTV provision was considered and some members were mindful of a number points made by the Police & Crime Commissioner in his recent visit.

Members were of the opinion that the personnel committee should meet in the very near future to discuss personnel issues that might have a budgetary impact, Recommendations from the meeting to be notified to the Full Town Council.

(Clerk's note: a Personnel Committee meeting is scheduled for Thursday 31 October 2019).

The volatility of some income streams was noted e.g. parking fees from Severn Park and the Cemetery.

Members were asked to write to the RFO before the 1<sup>st</sup> November regarding any specific budget suggestions (cost savings/ service reductions or increase spend/ additional services).
