FLAGS

The Town Council owns two Union Jack Flags, one for the Castle Grounds and one for Northgate. The Union Jack flown on Northgate on special occasions is beginning to look very shabby and starting to fray; whereas the one for Castle Grounds that is used less often is still in good order. Should Council agree to replace the flag at Northgate a new MOD spec, high quality, hand machined replacement would cost £122.88 plus VAT.

HASAW UPDATE
