- a- That the Town Council consider that more could and should be done to find a 3rd or more option(s). There are likely to be sites within the boundary of Bridgnorth that might be brought to the table.
- b- That the scale of development proposed is overstated.
- c- That evidence should be provided that verifies the proposed employment growth.
- d- That the Town Council would want to see a Local Housing Needs Assessment that justifies the proposed housing levels for the area.
- e- That removal of or significant reduction in safeguarded land is appropriate.
- f- That previous support for the development at Stanmore by the Town Council was conditional on infrastructure provision up front and at the start of the any development.
- g- That the Town Council would want to have evidence of the exceptional circumstances that justify development in the Green Belt (or the moving of it)
- h- That the Town Council would want a further consultation period as the late addition of the Tasley Garden Village proposal was not subject to normal and expected levels of consultation; a review/re-run of Regulation 18.
