#### 0383/1920 CHRISTMAS LIGHTING UP NIGHT

## i) Feedback

Overall, feedback had been extremely positive and the support from volunteers was praised.

Members were advised that a request had been received to reinstate the entertainment suitable for teenagers, such as the large funfair ride. Concern was raised that this may escalate the difficulties with antisocial behaviour which have significantly reduced over the past two years when the ride has not been in situ.

Members noted the increased police presence and committee members expressed their gratitude.

## ii) Date for 2020 Event

RECOMMENDED: that this year's Christmas Lighting Up Night takes place on Friday 20<sup>th</sup> November 2020 from 4pm – 8pm in Bridgnorth High Street in the same format as the 2019 event.

## i) Contingency Plan

Members considered a proposal that the event goes ahead on a reduced scale at a later date in either the Castle Grounds or Castle Hall, dependent on weather conditions.

The Town Clerk expressed concerns regarding staff requirements/costs should two dates be set as this restricts staff leave periods.

It was felt that securing a date for a smaller scale event gave participants advanced notice to secure vehicles/stock and shows the Council's acknowledgement of the work involved in participating.

RECOMMENDED: that a provisional date of Sunday 20<sup>th</sup> September 2020 be agreed for a reduced scale event, as in 2019, should the June event be cancelled due to adverse weather.

# ii) Marching Band

## iii) Fees

RECOMMENDED: that the following fees for the 2020 Carnival are agreed:

- Bars deposit of £100 plus 20% of takings (taking deposit into account)
- Caterers/Soft drinks deposit of £50 plus 20% of takings (taking deposit into account)
- Funfair, Inflatables etc) £50 plus 20% of takings (taking deposit into account)
- Commercial Stalls including Facepainting, Glitter Art, Balloons, Hair Wrapping etc - £40.00 plus VAT (£48.00 total)/ Double stalls £80 plus VAT (£96.00 total)
- Charity/Community Group Stalls minimum donation of £15.00 per single pitch

#### 0386/1920 **VE DAY**

It was agreed that the closing date for applications would be 28<sup>th</sup> February 2020 with grant funding applications being informed on 9<sup>th</sup> March 2020.

FURTHER RECOMMENDED: that Councillors S Barlow, S Stevens and Mrs V Hayward be appointed to the grants panel to consider and approve any such grant funding applications.

#### 0387/1920 BRIDGNORTH LIONS DUCK RACE

Members were advised that the Town Council has been approached by Bridgnorth Lions to seek their thoughts on a potential road closure of the bridge (Low Town) for one hour on Bank Holiday Monday, 13<sup>th</sup> April, from 1.30pm – 2.30pm. This is for spectator safety at their Duck Races which proved extremely popular at its inaugural event in 2019.

Members noted that Dave Mansfield of Shropshire Council has already been consulted.

Mr H Davies arrived at the meeting and gave an overview of the Lions' plans for the event and was shown various traffic management plans should the road be closed.

RECOMMENDED: that the Town Council has some reservations in closing the bridge as it will require a significant diversion route to be drawn up. A more appropriate solution might be to have an increased marshalling presence and seek advice from Highways as to how to achieve a safe event with a lighter touch traffic management scheme.
