MEMBERS QUESTION TIME

Councillor I Wellings posed two public questions. Both were answered by the Town Clerk

and Business Administrator

Question 1: Italian Auto Festival

"As BTC are not in favour of this event continuing in the High St for 2023. Has any

notification been sent the Event Organisers advising of this decision."

Answer: We have not informed them yet. However, if this is something the Council feels

needs to be done sooner rather than later, we can look to contact the organisers.

Question 2: Bridgnorth Musical Theatre Company

"As it would appear that this event is going ahead in the Town Hall according to press releases, have BMTC been advised that BTC will require the signing of a disclaimer which indemnifies BTC against any legal action for non-compliance with the Equality Act 2010, which incorporates the Disability Discrimination Act. Public Buildings are required by Law to

provide access for people with Disabilities."

Answer: BMTC are aware that the Town Hall does not have disabled access. However, they

have not been asked to sign a disclaimer. This is something that will be looked into.
