#### 0459/2223 PUBLIC QUESTION TIME

Members of the Public were asked to provide any comments or views.

A member of the public from St Leonards Close asked what a TRO was? They were informed that this was a Traffic Regulation Order. They informed they have given an individual response. They provided their view as being they didn't see why the change was being make as it was working at the moment and had done for so many years, the new options would be costing more money.

A member of the public from Church Street informed they had submitted their own comments and views directly but did not agree with the change from two permits to one.

A member of the public from Severn Street informed that there was no need to change as the current permit system was working, yes sometimes one was not able to get a space but this was rare but felt this was due to the Air B&B's in the area, the comment was that the member of the public believed that the changes were being made to make money in the budget for Shropshire Council and believed there was an ear marked efficiency in this area within their budget.

A member of the public from St Leonards informed that they did not agree with the two permits reducing to one permit and that one size fits all approach which seems to have been adopted by Shropshire Council does not work in these set of circumstances and made reference to the changes in Ludlow not working, that they could not rely on public transport in the area, they had concern with the extra houses in Tasley and with this brings extra parking requirements and pressure on the Town, where do they park then, it is not acceptable for them not to have parking spaces and why change it if it is not broken.

A member of the public from St Leonards Close informed they did not agree with the change from two to one permits, as they have all been able to park so why change.

A member of the public from St Leonards Close informed they had been living in the area for 42 years and had never had a problem with everyone having two spaces, they confirmed that sometimes they had a problem finding parking late at night due to the night time economy which with the free parking in the High Street was not necessary and suggested that these problems could be resolved with a pay to park as a way to stop people offending.

A member of the public from St Leonards Steps informed they had been living in the area for 19 years and didn't see a reason why they couldn't keep two permits and pay, to afford to live in Bridgnorth you had to have two salaries, which in turn is two cars as public transport is so terrible so not an option to use, house prices will go down and that is unfair, five bedroom homes have at least two cars as they are family homes and the late night parkers were not residents blocking the streets but people using the night time economy.

It was informed that nobody had a legal right to park on the streets.

Members are asked to debate the Shropshire Council parking consultation within the Bridgnorth area and agree on the Town Councils response for the individual streets included in the consultation.

Members were asked to debate the proposal put forward to include a standard response in each of the responses made to Shropshire Council as well as the resolution voted on. Members were provided with a copy of the standard response information and also the spreadsheet providing information for each individual road including the consultation information for each road.

Proposed by Councill Sawbridge, Seconded by Councillor Barlow Unanimously agreed by all Councillors

**RESOLVED**: that the Council agree for a blanket response to be included in each individual response sent back to Shropshire Council with the confirmation of the voting of against or support for each individual road as part of the consultation. This standard response to be as detailed below:

- Eligible Residents to only be allowed 1 & not 2 parking permits.
   Unreasonable where a property, wherever it is located, has no drive and no garage. If a property has a drive or a garage, it is reasonable to allow just one permit.
   +Location: East Castle Street, West Castle Street, Cartway, Friars Street, Waterloo Terrace, Castle Terrace. St Mary's Street, Listley St
- Eligible Residents will receive 200 hours of visitor permits per year.
   This seems to be unreasonable.
   200 hours p.a. is totally unreasonable and impractical eg visitors staying Friday through to late Monday could use 96 hrs. 200 hrs equates to 8 days p.a. or 4 weekends Sat through Sunday p.a..
   Location: Everywhere
- That any proprietors of holiday let properties may purchase a parking permit for use by their customers
  during the rental of the holiday let property.
  This seems inequitable to the residents (the proposal effectively prioritises the needs of visitors over the
  needs of residents).

Who has lobbied for and managed to achieve this ridiculous permit for Holiday lets? Totally disagree and requires striking from the scheme. People have stayed in Hotels, B&Bs and Holiday Cottages with no 'on-site parking' provision or 'free permits' for street parking. You have to pay to park at the nearest Public Car Park. Why should Bridgnorth continue with this theme that the Tourist is KING! The AirB&B's multiplying at a rate all over Town do not contribute to Council Tax or Business rates. Location: Everywhere

4. That owners of businesses will no longer be eligible to purchase parking permits.

This seems inequitable to the business operators eg B&Bs can no longer issue permits to their overnight guests, but holiday lets can?

This is unfair on the business community who certainly pay into the coffers of Shropshire Council via Business rates. It may be aimed at Commercial vehicles being left in residential areas, particularly overnight, instead of their drivers' business premises. This is a problem as the size of the vehicles means they don't fit in a parking bay and allow other vehicles to use bays either side. Again, due to their size, to allow access in narrow streets and roads, pavement parking is the norm with all the dangers that introduces. This is the issue.

THE SHROPSHIRE COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES) (CONSOLIDATION) ORDER 2009 (BRIDGNORTH) (AMENDMENT) ORDER

Bridgnorth Town Council is concerned that and requires confirmation in writing that the correct Legal procedures (as set out in in the Gunning Principles) have been followed when the Consultation Documents for the Proposed revised Parking Arrangements were issued to the Residents of Bridgnorth.

In the case of TRO consultations, there are procedural rules made by statutory instrument which require that proposals are open for comments for at least 21 days, and that a "statement of reasons" must be aiven.

We are not convinced Shropshire Council have provided sufficient information to give "intelligent consideration" to the proposals or that they can demonstrate having given "conscientious consideration" to what residents said in the engagement exercises held last December.

It is for the above reasons Bridgnorth Town Council cannot support these proposals at this time.

We would advise that Bridgnorth Town Councillors effected by these proposals will respond directly to Shropshire Council but as private individuals.
