1. Reference Bridgnorth High St closure- Sunday 27/08/23

Thank you for letting residents of town centre streets impacted by the festival & related alternative access to Cartway via Postern Gate. However, though the letter states the no entry on the High St/ Postern Gate junction would be suspended, there were no temporary signs in

situ. A number of Cartway/ Friar's St residents have been liaising with Bridgnorth & Shropshire Councils for a number of years to request promoters to:

- provide a notice letter.
- provide appropriate traffic signage (see attached)
- a barrier at the end of the High St
- appropriate stewardship in this location.

Unlike other town centre streets Cartway & Friar's St has a prohibitive traffic regulation order. In addition, attendees at events do not expect vehicles in this setting without measures, highlighted above, in place.
