0001/2324 **WELCOME**

The Chair issued a welcome to the meeting.

0002/2324 ELECTION OF CHAIR

It was proposed by Councillor I Wellings, seconded by Councillor R Connolly unanimously agreed by all Councillors present

RESOLVED: to appoint Councillor I Wellings as Chair of the Events Committee.

0004/2324 APOLOGIES FOR ABSENCE

No apologies for absence were provided.

0005/2324 **DECLARATIONS OF INTEREST**

None were declared.

0006/2324 PUBLIC QUESTION TIME

A member of the public, raised the following question:

Regarding High Street events, is it now time for a prepared check list of conditions to be presented to promoters which has to be fully signed off, with accompanying evidence, at least a month before an event date and in the event that undertakings are broken on the day, an application by any promoter will not be approved for the following year?

A member of the public, raised the following:

There are 3 issues:

- 1. Headship to local residents
- 2. Health and safety issue affecting residents and visitors alike
- 3. Taxpayers' concern at possible legal action against our 2 councils if both the former not being addressed in part or in whole.

- Residents are legally entitled to access to their homes in a non emergency., They may have other obligations on an event day and need vehicle access. With that comes the need to publish and manage road diversion.
- Residents and visitors are entitled to adequate health and safety measures such as emergency vehicle access.

Examples:

- Concerning health and safety plans, in the past vehicle access has been blocked by market stalls or expensive motor cars.
- Concerning residents' access, on far too many occasions there has been inadequate provision for those living in Cartway and Friars St and Old School Mews in particular. Ie. There has been no notification of event details in whole or in part, including diversion through Postern Gate, no marshals to enforce access, misplaced signage, etc.

In short, current procedures are completely inadequate because promotors are not it seems not signed up to proper conditions.

The Chair informed that the Town Council was working on a checklist to provide to all event organisers who were seeking a road closure for High Street, this would include information and communication required for the road closure and updating the residents.

A member of the public, Mr Edward Marshall, asked to read the following statement:

As members may be aware, Bridgnorth Town Council is currently involved in an unexpected large and financially expensive project. Bridgnorth Town Council is basically funded by the residents of Bridgnorth Town and any significant increase in the cost of running the Council likely to lead to an increase in Council Tax paid by the residents. I note the following items on tonight's agenda which could be rejected with no adverse effects on the services provided by the Council to its residents.

Item 9. Coronation Tea Party. I specifically refer to the reference to set a provisional date for next years event. In the past 2 years there have been Tea Parties funded by the Town Council or part of the celebrations including Royal Events. I have heard that everyone who attended the Tea Party thought them to be a great success, although many attendees were clearly able to look after themselves and pay costs involved. Next year, there is no significant National Event meriting a celebratory Team Party, so why is the Events Committee giving consideration to holding such a tea party next year?

Item 13, Bridgnorth in Bloom. There is a request from Love Bridgnorth for the Town Council to become involved in the Annual Bridgnorth in Bloom competition by providing the necessary (amount not specified) to purchase rosettes and prize vouches.

Why can't Love Bridgnorth raise this money themselves from the businesses in Bridgnorth who presumable they have some contact, rather than residents of the town.

Also, who is / are Love Bridgnorth? Does Bridgnorth Town Council have information about the owners of Love Bridgnorth, membership if any, accounting, etc.

The Chair confirmed that the Tea Party held in May 2023, was paid for using a grant which the Town Council applied and were successful in.
