PLN/008/2324 MEMBERS QUESTION TIME

There had been no questions raised prior to the meeting.

Councillor K Sawbridge raised a general point regarding signage around the Town and what the Planning Committee could do to improve the standardisation of signage.

Councillor D Cooper informed that signage required planning approval and there were some standards that were required to be met due to Bridgnorth being in a conservation area. Councillor D Cooper confirmed he would circulate the rules information to all members and the option would be to raise this as a planning enforcement case to Shropshire Council.

Councillor K Sawbridge raised the issue of the graffiti on Stoneway Steps.

Councillor D Cooper informed this needed to be raised on FixMyStreet with Shropshire Council and could also be raised as a discussion point at a Full Council meeting.

Councillor I Wellings raised the issue of mobile homes parking overnight on the road in Riverside and informed that there was clause for the Riverside houses that no mobile homes could be parked on the drives and in the area and how this could be stopped for visitors who park overnight.

Councillor D Cooper informed that this would be difficult to enforce and manage, if it was illegal parking then this would be parking enforcement for the land owner or if dangerous parking a police matter.

Members received a verbal updated from Councillor D Cooper who informed that Shropshire Council Cabinet had approved a response on the 19th July 2023 but this had not been submitted to inspectors to date. This included the proposed new policy for older persons and the identification of suitable locations to accommodate the overspill from the Black Country, including locations to build.

Members discussed the creation of a working group for the review, comment and watching brief of the Shropshire Draft Local Plan.

RESOLVED: to agree for a working group to review, comment and have a watching brief of the Shropshire Draft Location Plan and agree for Councillors D Cooper and I Wellings to be part of the working group. For the Town Clerk to email all Bridgnorth Town Councillors and ask for if any other member would like to join the group and for this working group to be retrospectively noted at the next Town Council meeting.
