Members were asked to consider a first quarterly budget report. The report highlighted the expenditure budget lines that had exceeded 25% of the budget at the end of the accounting period month 3 and where the cash value of overspend is greater than £250.

The Chair gave Members the opportunity to ask questions and the report was discussed in detail. No major issues were identified. Expenditure on the retaining wall project was in line with expectations but Members noted that the delay in

Members were informed that the insurance policy had been renewed for 2023/2024 with brokers James Hallam.

**RESOLVED:** to delegate to Officers the task of procuring a Cyber insurance policy through James Hallam once the relevant checks had been carried out with regards to the levels of cover.

Specific nominal codes are to be set up for both income and expenditure to deal with movements to and from Earmarked Reserves.

Members also looked at major income variances and discussed revenue underspends. Pending the production of a detailed forecast outturn the Committee was assured by the RFO that the revenue budget, excluding the exceptional item of the retaining wall, remains achievable.
