PLN/25/2324 TOWN CENTRE, SHOP FRONTS AND SIGNAGE

1. The Committee received an update from the Chairman of the Planning Committee regarding the legislation and regulations that deemed consent with condition for signage / advertising and within a conservation area and the requirement for planning permission where the larger signage / advertising is required as part of the regulations. An update was provided for the possibility of applying for a designated area of special controls through Shropshire Council with the Secretary of State providing consent for this, this would need to be investigated further. It was confirmed that under Bridgnorth District Council there was an Urban Design Guide but it was unsure if this was adopted by Shropshire Council and still in place, as well as unsure if this dealt with signage. The buildings in the High Street are predominantly grade 2 listed and the specific guidance on advertising restrictions on what can be refused.

It was debated that in respect of listed buildings colour pallets that are in keeping with the buildings and the conservation area could be explored and could be discussed with the BID for consideration as part of the project and also Future Bridgnorth Project. It was debated that the Shropshire Council Conservation Officer would be approached to discuss the possibility of a colour pallet and what statement could be included to adapt an approach (Design Guide) for the shop frontages and High Street to advise on what standards could be used.

It was proposed by Councillor I Wellings, seconded by Councillor D Cooper Abstained by Councillor R Ireland

RESOLVED: for the Town Clerk to approach the BID team, Future Bridgnorth Project and Shropshire Conservation Officer to explore the opportunity to standardise the colour pallet to be used by shops and businesses in the future with an appropriate design guide for the town.

RESOLVED: to object to planning reference 23/03707/ADV, with the objection response to be: A shorter Totem than was previously proposed does not address the issue of visual clutter and adverse effect on the amenity of the area which formed the basis of the refusal under 23/02320/ADV.

RESOLVED: to object to the following planning applications:

23/03702/ADV – Objection response to be, the lettering and logo proposed for the fascia sign appear disproportionately large compared with signs on nearby properties and we would prefer a smaller font size to be used.

23/03705/LBC – Objection response to be, whilst we appreciate that the proposed signage is similar in character to that of the previous occupiers of the building, we feel that a more muted fascia colour would be appropriate for this Grade II* building and would prefer the use of painted rather than applied acrylic lettering and logos.

Members debated the questions question raised from a resident via Councillor I Welings regarding if the High Street was a Alcohol Free Zone, it was confirmed it was not, and the issue raised with all the outdoor areas for drinking outside premises at times overspill and boundaries not defined that the general public had to walk on the road to get past these areas. The premises licences and pavement permits were debated.
