UPDATE ON THE PLANNING MEETING HELD ON 3RD OCTOBER 2023 BY COUNCILLOR DAVID COOPER

Members received the following verbal update from Councillor David Cooper – Chair of the Planning Committee.

'Advertising - many forms of advertising (for example, signs on buildings) are given "deemed consent" under government regulations and planning permission is only needed in limited circumstances (such as where signs are proposed to be larger or more numerous than is given deemed consent under the regulations, or where they are proposed to be illuminated within a conservation area. Generally it is not possible for consent to be refused on the basis of the colour or content of the advertisements, the main considerations are any effect on public safety or local amenity.

Telecommunications - the installation of poles or cabinets to provide broadband connections are often permitted development (subject to following a national Code of Practice) and generally would not require a planning application. Residents can, however, lodge an objection with the provider if they are aggrieved by a proposal. Openreach are planning to begin installing fibre broadband in the area covered by the Bridgnorth telephone exchange within the next 12 months so we may see a lot of cabling activity around the town.

Notable planning application - we've recently been notified that an appeal has been lodged against Shropshire Council's refusal to permit an access road to be cut into a roughly 8 metre high cliff face on Friars Street. The application will now be decided by the Secretary of State following the consideration of written representations by a Planning Inspector.'

0141/2324 UPDATE ON THE EVENTS COMMITTEE MEETING HELD ON 12TH SEPTEMBER 2023 BY COUNCILLOR IAN WELLINGS

Members received a verbal update from Councillor lan Wellings – Chair of the Events Committee.

Councillor Wellings informed the meeting that the Events Committee had been activate over the past months planning events and promoting the availability of the Town Council venues. They have compiled a High Street promoters check list which has been very well received in meetings that have been held with organisers. It is designed to make the organisers aware of their responsibilities with regards to the Town Councils required standards for public liability insurance, health & safety and temporary signage etc.

Successful events have been the Teddy Bears picnic, the Senior Citizens tea party, the Italian Auto Moto Festival and various charitable events in both Castle Grounds and Crown Meadow.

Forthcoming events include Remembrance Sunday on Sunday 12th November and the Christmas Lights switch on Friday 24th November at 6.30pm. Councillor Wellings wished for special thanks to be given to a member of staff, Emily Overton, for the incredible job that she has done with the organisation and planning of both the Remembrance Sunday and Christmas lights event.

The Town Council has been asked to consider our participation in the D-Day 80th Anniversary celebrations on 6th June 2024. This will be discussed at the Events Committee with details being brought before the Council in due course.
