A member of the public, raised the following question:

- 1. Reference Bridgnorth High St closure- Sunday 27/08/23
  Thank you for letting residents of town centre streets impacted by the festival & related alternative access to Cartway via Postern Gate. However, though the letter states the no entry on the High St/ Postern Gate junction would be suspended, there were no temporary signs in situ. A number of Cartway/ Friar's St residents have been liaising with Bridgnorth & Shropshire Councils for a number of vears to request promoters to:
- provide a notice letter.
- provide appropriate traffic signage (see attached)
- a barrier at the end of the High St
- appropriate stewardship in this location.

Unlike other town centre streets Cartway & Friar's St has a prohibitive traffic regulation order. In addition, attendees at events do not expect vehicles in this setting without measures, highlighted above, in place.

It was agreed by the chair that a written response by the Town Clerk will be sent to the resident as they were not in attendance at the meeting.

# 0024/2324 CHRISTMAS TRACTOR RUN-SUNDAY 17TH DECEMBER 2023

Members met with the event organisers for the Christmas Tractor Run which is due to take place on Sunday 17<sup>th</sup> December 2023. A run through of the events checklist produced by the Town Council was discussed with the event organisers. A plan of the day was also discussed with members by the event organisers.

## 0025/2324 CHRISTMAS LIGHTING DISPLAYS- REVIEW

Mr Stoker from Lightwire Electrical, attended to provide members with an update of the new documentation required from Shropshire Council Highways for the erection of the lights for 2023. The Grounds and Services Officer is to work with Lightwire Electrical to get this documentation in before the deadline and liase with Shropshire Council for the appropriate testing's required on lampposts and fixtures. An update was also provided with regards to our festive light inventory and proposals were made for changes to future displays. Members are to review the lighting inventory and budget for 2024.

It was proposed by Councillor S Barlow, seconded by Councillor C Aked and **RESOLVED** to reinstate Standing Orders for the remaining agenda items.

## 0026/2324 Riverside Slipway Permits

Members were provided with a verbal update from the Grounds and Services Officer with concerns raised by slipway permit holders. Discussions were held with members in relation to the ownership of the slipway and appropriate signage going forward. It was decided this item is to be discussed at a future meeting once further research has been carried out by the Grounds and Services Officer.

It was proposed by Cllr R Ireland that the slipway permits be discontinued for 2024. There was no seconder to this proposal. The motion was not carried.
