# **DLF and Environmental Update Report**

### **Background and Update**

We currently have four full time positions:

- 1 x DLF Supervisor
- 3 x Operatives

There are currently three vacancies within the DLF team.

# **Hanging Baskets**

The hanging baskets this year has been reduced to 180, the amount of bedding plants has been reduced and replaced with perennials.

In 2022, the weight testing on the hanging basket poles was carried out after one fell from the Town Hall. The previous Property and Grounds Manager organised the testing on the Town hall and clock tower only, with an outside contractor. The remainder of the hanging basket poles have not yet been tested. Load testing quotes are being obtained and will be brought to a future Town Council meeting for consideration.

#### Play Area

Due to the age and heavy use of the play equipment, the inspections both internally and by ROSPA are highlighting many pieces of equipment needing immediate repairs as well as long term changes. This will have an impact on the budget. It has been identified that over the last few years repairs to the play equipment has been kept to a minimum due to the insufficient budget.

It has been identified that the Town Council may be required to make decisions regarding play equipment and if equipment fails this would be to

- (a) remove the piece of equipment
- (b) replace this piece of equipment
- (c) repair but note that spare parts are required to be purchased from the manufacturer which can result in being costly.



There are pieces of equipment on Severn Park play area, which are supported by bark for the safety of the users. This piece of equipment is within the flood plain which means we have to replace the play grade bark at a cost of £130 per tonne. This is completed twice a year.

There will be a requirement this year for all the play grade bark to be fully replaced due to the age and settlement due to the high usage.

In previous years when it has flooded, the play grade bark has not been removed or replaced, only topped off with new bark. Going forward the Town Council may wish to consider the removal of the spider's web, and have it reinstalled at another play area which will eliminate the need to reinstall bark each time the above area floods.

The Fitness Equipment within Severn Park was installed in the flood plain area also. This has resulted in the equipment starting to rust and break. The fitness equipment will need a greater number of replacement parts, and this will become more frequent as the equipment ages. A future report will be submitted on all play areas by the DLF Supervisor.

#### **Tractor**

The tractor is used to cut all the large areas around Bridgnorth including Well Meadow/Crown Meadow/Severn Park.

The Tractor is eighteen years old and has had several repairs carried out on this vehicle in the last five years due to its age.

Unfortunately, the tractor is now off the road due to an oil light indicator on the control panel. Two contractors have looked into this problem, and they have both done an oil test on the vehicle, which concluded the tractor is no longer holding oil pressure. Due to this problem the tractor cannot be used and is now in the compound until an action plan can be put together to resolve this problem.

Three quotes have been sought for the repairs to the tractor. Unfortunately, one contractor is no longer in the position where he can take on the repairs. Without this tractor the grass areas listed above will not be cut.

# Ride on Mower and Trailer

Following the break in at the Cemetery in December, one of the rides on mowers and the trailer was stolen. Due to the amount of grass cutting, which is undertaken in all areas around the Town, a new ride on mower is important for the DLF to function correctly. The insurance company has been contacted with all the relevant information details but may take several weeks to be resolved. Now that grass cutting season is here Could the Town Council purchase these items in advance of the insurance claim being resolved so day to day activities can function correctly. In order for the DLF to presume with maintenance works, a new mower and trailer are required.

**Recommendation:** Members are to consider purchasing a replacement mower, with quote three at the cost of £10,030.00.

#### **Trailer**

**Recommendation:** Members are to consider proceeding with quote two. The trailer in quote two has the same specification as the one stolen and covers all requirements to take the weight of any machinery we need to transport.



### **Health and safety**

Work has been completed following the Health & Safety Audit and all items in our chemical safe have now been professionally removed. We now only store one specific chemical (Roundup).

We are always working at better ways to improve our work surroundings.

### **Training**

There are several pieces of equipment that require formal training to enable the DLF team to use the specific equipment.

There are currently some areas that need to be addressed for specific training needs. (this is referred to internally as a ticket).

Training required for specific equipment:

- Chainsaw currently no qualified operatives. Cost Circa £850.00
- Spraying requires two DLF operatives.
- Road assistance requires one operative.
- Tractor all staff need a refresher course on this as normally only one operative uses the tractor.
- Abrasive wheels requires one DLF operative.

All members of staff are now ladder trained and competent in using the apparatus and identifying any problems. We are currently working on a Training Matrix Plan which will be presented to the committee at a future Town Council meeting.

**Recommendation:** For members to allow one DLF operative to obtain the chainsaw certificate at the cost of £850.00.

#### Removal of Rubbish

All green waste is taken directly to Shorthouse's by DLF operatives. This has made a massive difference in the way we work as there is no longer the need to have stockpiles at the Cemetery waiting to be burnt. This has allowed us to be more efficient in the way we work and allows us more time to carry out other task within the Town. Onsite burning of rubbish no longer takes place.

Is it suggested going forward that the general rubbish from all park areas could be disposed of in this same way. This would reduce the waste deposited in the large skip at the Cemetery which is often sat for long periods.



# **Additional Plant and Machinery**

It has been identified that there is a requirement for additional machinery.

Items required are as listed below: (it is estimated the cost for this is circa £9,000)

- Small 110 generator for watering (this will reduce the manual handling issue and make watering more efficient and save on journeys to and from the cemetery circa £1000.00
- 1 x petrol long handled hedge cutter.
- Chipper for clearing our woodland areas this will also require operative to be trained (Chipper £6000) (Training to operate £200)

**Recommendations:** Members are to consider the purchasing of the additional machinery as well as for one DLF operative to be trained to use the chipper.

#### **Future Projects**

Detailed below are the list of future projects:

- Castle Grounds: rose borders to be removed and grass seeded over.
- Cemetery memorial garden steps.

# **Cemetery Compound Break In**

More security measures have been made to improve the security at the Cemetery. Two new drop-down barriers have been positioned outside the compound gates as well as new locks for the chapel doors. Due to having no electricity up at the compound no CCTV cameras can be fitted in that area.

#### **Adverse Weather Conditions**

The heavy rainfall this year has caused the river to flood once. As a team we have reacted to this situation promptly by distributing sandbags to the affected areas before the river peaked. We have several pallets of sandbags on standby and ready to go if this should happen again.



#### **DLF Staff**

Two operatives retired in December 2023, there are now only three DLF members of staff and one DLF Supervisor. There is need for at least two new members of staff for the Town Council to consider employing due to the time of year. Once all the hanging baskets and bedding have been put out, it will take almost (40 hours for two operatives) to carry out the watering round which will include early starts.

# **Winter Work**

Work to be concentrated on during the winter months will consist of cutting the hedges in all BTC maintained land, maintenance to all play areas and shrub beds. Ongoing maintenance and daily duties to carry on at the Castle Grounds and Cemetery.

# **Castle Grounds**

Following retirement of two members of staff last year there is currently no need for someone to be employed in the Castle Grounds full time at present. However, this may change in the summer period.

The full length of the nature trail has been cleared out and we are looking to install some new wood carvings and reopen this area in the summertime. I have received a lot of positive comments regarding the Castle Grounds on how good the area is looking.

The bridge has deteriorated and has been removed for safety reasons. The maintenance team is working on this, and it should be replaced by Easter.

# **Tree Report 2024 (All Areas)**

Shropshire Council have caried out half the tree report for Bridgnorth Town Council parks and woodland areas, they have highlighted a list of affected areas that require attention.

The list has been split into areas and the works has been highlighted, there is a lot of work that can be undertaken by the DLF Team, however, there are areas that will have to be completed by an outside contractor. Contractors will have to be contacted to obtain quotes once Town Council has approved.

DLF staff have carried out remedial works to the below areas and work has allocated into three areas:

- DLF to complete minor works.
- Watching Brief Arboriculturist to monitor.
- Contractor to complete more complex maintenance.

The DLF have completed all works on these reports. Where a contractor is required to complete works the DLF Supervisor will complete a procurement process and a report on costs will be brought to a future meeting.
